



MINISTER'S REPORT

Therefore I tell you, do not worry about your life, what you will eat or what you will drink, or about your body, what you will wear. Is not life more than food, and the body more than clothing? Look at the birds of the air; they neither sow nor reap nor gather into barns, and yet your heavenly Father feeds them. Are you not

of more value than they? And can any of you by worrying add a single hour to your span of life? And why do you worry about clothing? Consider the lilies of the field, how they grow; they neither toil nor spin, yet I tell you, even Solomon in all his glory was not clothed like one of these. But if God so clothes the grass of the field, which is alive today and tomorrow is thrown into the oven, will he not much more clothe you—you of little faith? Therefore do not worry, saying, 'What will we eat?' or 'What will we wear?' For it is the Gentiles who strive for all these things; and indeed your heavenly Father knows that you need all these things. But strive first for the kingdom of God... Matthew 6:25-33

What do we need to be happy? What do our neighbours need to be happy? What does the world need to be happy? Let's start with the basics; we need food, clothing, fresh air, water and a place to rest. Beyond that what do we need? We need each other, we need community, we need purpose, and we need a reason to get up every morning. We need a place where we can sing our song, individually and collectively.

Faith is the awareness that there is a Creator who invests us with the necessities of life, the purpose of life and the covenant of community to give and receive love. Here at Bethany I have felt my faith grow. The necessities are here, thanks to the Capital Campaign committee who have raised many dollars to make our building safe, accessible and inviting, thanks to our Treasurer Linda who makes us collectively good stewards, thanks to the Board of Managers, who monitor our assets and utilize them in a most effective way and thanks to our hard working staff who carry out their mission and ministry with care, passion and faith.

But to be happy we need each other too. And we need to listen to each other. I talk a lot. But I listen too. People are surprised how I remember their words but not physical details. My faith is growing and I am anxious to hear wisdom from every voice, new or familiar. Our Wednesday senior days, our Joy Lunch Tuesdays, our choirs, our Wednesday afternoons for young students, our Sunday nights for youth, our faith studies, our Community Care Ministry, our Community Lunches, our Muffin Club, our conversation circles with ISANS, our Fall Fair, our plays, our parties, our coffee hour after worship services, these gatherings provide us with access to inviting space, caring people, a Spirit of fun and love and growth, and most importantly, God's enduring Presence.

There is a reason our sacred texts include stories of Creation, our God wishing for relationship and creating water, sky, vegetation, animals and then us, stories of relationship like Ruth and Naomi, stories of surprising relationships like the Good Samaritan, stories of challenged relationships like the Prodigal Son and stories of Divine Presence like the Great Commandment (wherever two or three are gathered...). And that reason is holy community, where we can experience God, grow with God and become whom God wishes us to be, individually and collectively.

If there was one lesson we learned in 2019, that we learn every year and that I pray we learn again in 2020, it is that each of us has something to teach the other. All of you who come to church sit there and listen to me offer a sermon. You listen to me. But I listen to you too. I visit, I seek you out for your opinion, and I always want us to express our vision as a team. I may be loud and extroverted but my philosophy of community is to "wait upon the Lord" for expressions of organic wisdom and vision. It is easy for Ministers to suggest a course of action and then by their position force others to go along. (Though that never really works out.) I prefer to listen and when I discern a consensus emerge that sounds like the God I know articulate that to our larger community with my loud voice.

And in closing let me say I count on the wisdom, humility and knowledge of our extraordinary Executive Board Chair David Rackham. David's health has been fragile of late but his spirit is strong. If you ever need good counsel please speak to David.

Each of us know something of happiness. Each of knows what we need and what we don't need. I need God in my life. I need community in my life. I need your wisdom and your vision. And when sadness, pain and loss comes, and it is part of the human experience, I need your prayer shawls, hugs, tears and soup, because community comes when we are sad and when we are happy. I need your laughter and your humility. None of us have this all figured out and that is why we are called to be together. And most of all, I need your joy, in good times and bad, knowing who we are and whose we are.

Come and be happy with me. Peace, Kevin

PRAYER AND MEMORIAL LIST: Rev. Kevin Little read the Memorial List and proceeded with a prayer to open the Annual General meeting.

Board of Managers

Chair Gordon McMillan has retired from the Board of Managers after many years of faithful stewardship of our premises, and we thank him for his outstanding service.

Greg Rice has completed a three-year term and is willing to serve a further three-year term, if elected, and we hereby nominate him.

The Board of Managers has advised that it does not require new Board members in 2019.

Executive Board

Lyn McMillan has retired as a member-at-large from the Executive Board, and we thank her for her service.

Les Russell has agreed to serve another one-year term as a member-at-large on the Executive Board, if elected, and we hereby nominate Les.

As well, John Lorimer has agreed to serve a new three-year term as a member-at-large on the Executive Board, if elected, and we hereby nominate John.

Pam Carter has served Bethany faithfully as its representative to Halifax Presbytery over some three decades, and the words "thank you" seem somehow insufficient for that kind of service. The Halifax Presbytery representative has always had a dedicated seat at the Executive Board, which means that Pam has been an equally valued member of our Executive Board for all those years. The old Presbytery system is now at and end, and all Nova Scotia Presbyteries have been replaced by a new Regional Council covering all of Nova Scotia and Bermuda. With this change, Pam has decided to step back from acting as a representative to the new Council, but has agreed to serve another three-year term as a member-at-large on the Executive Board, if elected, and we hereby nominate Pam.

We are also pleased to advise that Grant MacKenzie has agreed to serve as Bethany's first representative on the new Regional Council, if elected, and we hereby nominating Grant to this important inaugural role.

Bethany United Church has the right to send up to four (4) representatives to the Regional Council, of which Grant would be one, if elected. The Nominating Committee understands a further resolution will be proposed at this Annual General Meeting to address the nomination of future representatives.

Gloria Stephens was appointed as Recording Secretary after the Annual Congregational Meeting on March 25, 2018, with the understanding that she would be officially confirmed today. Accordingly, we officially nominate Gloria to that role, with effect as of and from March 25, 2018, and we thank her for stepping forward. It is an important role.

On behalf of the Nominating Committee, I now invite the Chairs or Secretaries of each of these Boards and Committees – Session, the Board of Managers, the Board of Trustees, and the Executive Board – to reach out to the new members of your Committees to provide them with minutes from your last meeting and to provide your new members with notice of the next meeting.

The Nominating Committee would like to thank all those volunteers who officially complete their service on these Boards and Committees, all those who have agreed to renew their mandates, and all those who have agreed to serve under new mandates on behalf of our congregation. Their efforts help lead us as Bethany builds the New Jerusalem. We are blessed by their countless hours of dedicated service to the life and mission of Bethany in the world.

I would like to thank Amy-Sue Bowers and Heather Brophy for their support on the Nominating Committee this year.

Special thanks to Rev. Kevin Little for his considerable assistance as well, once again this year. He knows more potential Bethany volunteers than Facebook has members.

Special thanks as well to the Chairs, Carol Knapp (Clerk of Session), David Rackham (Executive Board), Andy Williams (Board of Trustees), and Gordon McMillan (Board of Managers) for their support of our work over the past year.

Thanks as well to Dana Mills, who is always professional and helpful.

All of the foregoing nominations to the Board of Managers, the Board of Trustees, the Executive Board and Session are respectfully submitted, and so moved.

EXECUTIVE BOARD REPORT

The Executive Board (EB) is generally responsible for exercising "overall" leadership in the care and oversight of the spiritual life, activities and the work of the Congregation, the care and maintenance of the church property, and to act as a liaison between the Congregation and Halifax Presbytery, now dissolved and replaced by the Region 15 Council. Of course, there are various specific boards and committees that do an excellent job of taking care of day-to-day matters in these various domains. Their reports may be found elsewhere in this Annual Report 2019, but all have representation on the EB.

In receiving and disseminating reports from the various boards and committees that comprise the governance framework (polity) of Bethany United Church, the EB, as the most widely representative body of the congregation, also serves the important function of keeping people informed of the ongoing activities, opportunities and challenges faced by the Bethany community as it seeks to be an instrument of God's kingdom here on Earth.

Historically the EB has met an average of five times during a given calendar year, but recent years have required additional meetings given a number of significant matters that required action by the EB. Fortunately, 2019 has been a relatively benign, hence "normal", year in terms of the number and urgency of matters requiring consideration by the EB, thus fewer meetings than were required in the last two or three years. I express my deep appreciation to all members of the EB and the Bethany community at large for their encouragement and support throughout 2019.

The new three-court model of the United Church governance structure came into effect January 1st 2019. With that major change in the overall United Church governance structure, Halifax Presbytery ceased to exist, as did Maritime Conference, with those two bodies being condensed into what is known now as the Region 15 Council. Bethany has two representatives to the Region 15 Council approved by the EB, namely Grant MacKenzie and Rev. Kevin Little. We thank them for their willingness to serve in this important capacity.

The EB has appointed an *ad hoc* committee to look into the implications of these changes in the overall United Church governance structure for Bethany's own local system of governance but so far we await details of implications of these changes at the higher courts of the church for local churches like Bethany. This committee will presumably get under way in 2020 once we are informed of specific changes in the structure and function of Region 15 that will have an impact on our local system of governance. This committee will also look at possible efficiencies that might be introduced into Bethany's current system of governance.

The Option 1 Renovation programme for Bethany United Church is well underway and is under the ultimate supervision of the EB. However, the EB has delegated the day-to-day implementation of this programme to the Board of Managers who provide regular feedback to the EB on the ongoing state of the programme, including its various financial aspects. A report on progress to date will be presented at the March 2020 Annual Congregational Meeting.

Specific Matters of Business Addressed by the Executive Board in 2019

- Approval of terms and conditions for recruiting and hiring of a Finance Officer.
- During the course of 2019, and in the interests of transparency, the EB approved publication of the minutes of Annual Congregational meetings on the church's website (http://www.bethanyunitedchurch.ca).
- The EB is fully cognizant of how fortunate Bethany is in its staffing complement which currently includes Rev. Kevin Little (Lead Minister), Shawn Whynot (Director of Music), Ann Bradley (Community Engagement Facilitator), Louisa Duck (Children and Family Care Ministry), Dana Mills (Ministry Resource Support), Jim Sweet (Caretaker), and Tina Gascon (Finance Officer). All staff members go well beyond any formal obligation of duty in supporting the Bethany community and the EB has been seeking an appropriate and tangible way to express our collective appreciation for their efforts. At Christmas time 2019 a personalized letter of appreciation was sent to each staff member along with a gift card which, as noted, was symbolic of how much they are appreciated by the Bethany community. Efforts will continue in 2020 to formalize a protocol by which we can express our appreciation to staff members on an ongoing basis.
- As requests for raffles to support Bethany United Church charitable and outreach activities have increased over the past year, the EB decided to try to develop a church-wide raffle policy rather than continue to examine each request on a case-by-case basis. Accordingly, an ad hoc committee consisting of EB members Karen Finley, Karen Hatcher and Carol Knapp was struck to inquire into this matter. Eventually, a draft raffle policy was formulated for purposes of discussion by the full EB membership. Receiving tentative approval by the membership, legal vetting of the draft policy was then sought before seeking final EB approval. We are most grateful to Bob Carter for rendering his expertise in this regard. The final version of the policy was approved by the EB at its December 2019 meeting.
- Since the single minister policy was introduced on an experimental basis by the Executive Board, it has been reviewed on an annual basis to determine if it is still producing satisfactory results for all concerned. The EB determined that the single minister policy is fully worthy of continuance but will be reviewed again toward the end of the 2020 calendar year. It should be noted that what has made the single minister regime so effective is the extraordinary dedication of our minister, Rev. Kevin Little, along with the support of staff members, especially Ann Bradley, who also does an extraordinary job in offering Bethany's outreach programmes to both the Bethany community, itself, and to the wider community of which Bethany is a part. Together Kevin and Ann, along with the support of other members of the staff, fulfill the duties formerly handled by individuals holding the Minister of Visitation position.
- A job description for the Ministry Resource position was prepared by the Ministry & Personnel (M & P) Committee and formally approved by the EB during the course of the 2019 calendar year. This process should continue throughout 2020 until job descriptions for all staff positions have been updated.

- Each year the EB examines and approves the budget for the forthcoming fiscal year.
 Such was the case again in 2019. Formal and final approval of the budget occurs at the Annual Congregational Meeting.
- The EB approved a request by the co-chairs of the Community Connections Working Group to support a quest for installation of a digital sign for Bethany which would bring attention to the activities of the Bethany Community to the wider community on an ongoing basis. Funds were acquired to partially cover the cost of this sign, which is now in place and operating, with fundraising efforts planned for 2020 to completely pay for the purchase and installation costs of this sign.
- At the request of the current chair, the EB has agreed to look into appointing a vice-chair of the board following the 2019 Annual Congregational Meeting (to be held in March 2020) as a means of encouraging a smooth transition between chairs as their terms expire. The current chair's term will expire with the Annual Congregational Meeting to be held in March 2021, and it is hoped that with a vice-chair in place, subject to the confirmation of the EB membership following the 2019 AGM, that individual will be able to slip smoothly into the chair's position in March 2021.

Resignations and Changes in Terms of Service by EB Members During 2019

- A letter was received on February 8th, 2019, from Gordon McMillan, Chair of the Board of Managers at that time, indicating that he would be resigning from that position and thus, from the Executive Board as the Chair of the Board of Managers automatically sits on the EB. This resignation was received with regret and on behalf of the EB the chair communicated the board's great appreciation for yeoman service rendered by Gordon on Bethany's behalf over many years.
- Carol Knapp, former Clerk of Session, resigned that role effective June 2019, and with that resignation her membership of the EB came to an end as the sitting Clerk of Session automatically sits on the EB. Janet Sponagle Hopper was welcomed to the EB replacing Carol as Clerk of Session. Great appreciation was expressed to Carol by the EB membership for her excellent service not only to the EB but to the Bethany community at large.
- Dave Reid, long-term chair of the M&P Committee, was finally able to complete his
 extended term of service in that capacity and with that he left the EB to be replaced by
 Bob Grant, the new chair of the M&P Committee. Needless to say, the EB has been
 extremely fortunate to have Dave as a member of the EB representing the M&P
 Committee for far longer than he had any formal obligation to serve in that capacity. Many
 thanks to Dave for his yeoman service to Bethany for so many years.
- The EB has had the privilege of having two individuals represent the youth constituency of Bethany United Church. Regrettably, both have had to tender their resignations during the course of the year due to other obligations that made it very difficult for them to attend EB meetings. The EB greatly appreciates the service rendered by Peyton Duggan, now a student at Queen's University in Kingston, Ontario, and Charlotte Moase, a student at Dalhousie University here in Halifax. It is not easy to recruit youth members to any of our boards and committees so we are especially grateful that Peyton and Charlotte were able to share their time and talent with us for as long as they could.

With the dissolution of Halifax Presbytery on January 1st 2019, Pam Carter, who served
as Bethany's representative to Presbytery for many years, thought it appropriate that
another individual be identified who would be willing to represent Bethany at the newly
established Region 15 Council. The EB approved this idea and subsequently Grant
MacKenzie and Rev. Kevin Little were approved by the EB and are now actively serving
as Bethany's representatives to Region 15.

Individuals Serving the Executive Board in 2019

The Executive Board has been most fortunate in its membership throughout 2019. The dedicated, hardworking individuals listed below go well beyond any formal call of duty for their service to the Executive Board and, indeed, in many cases, concurrently to other boards and committees as well. Without this willingness to contribute time and talent to Bethany, this community would be hard pressed to survive, let alone prosper, as it currently seems to be doing. As chair, I am extremely grateful for the kindness and support I have received from the membership through 2019. Without that, nothing could be accomplished.

Ministry and Personnel Committee

The Ministry and Personnel Committee (M&P) consists of church members or adherents selected to support staff relationships. Duties of the M &P include carrying out regular interviews with each staff member, reviewing working conditions, and overseeing the relationship of the staff with members of the congregation and with each other. Any matter brought to the Committee is kept in confidence.

The Committee reports to the Executive Board. During 2019 the Committee held interviews with each staff member in June.

Any member or adherent of the congregation may ask to meet in confidence with the Committee as a whole or if preferred one-on-one with a member of the Committee or submit a letter to the Committee

BETHANY BOARD OF MANAGERS

Bethany Board of Managers summary of 2019:

- The new concrete ramp door is near completion. The recent installation can accommodate manual ingress and egress. The push button and "card swipe" mechanisms will be installed in the early winter of 2020. This "door system" will allow both large item deliveries and access for mobility devices.
- The digital sign is in operation. Although training to post images and messages has concluded, office and other staff continue to exercise their creative talents providing digital messages that are receiving positive feedback from Bethany congregants and the public.
- New exterior lighting has been installed and commissioned. The fixtures are located on the Joseph Howe Drive side of the Fellowship Hall, the wall adjacent the concrete ramp, Office entrance and the large parking lot wall facing the Canadian National Rail Way line. The latter installation required new wiring as the existing wire proved to be a fire hazard. All new lighting is equipped with LED bulbs.
- Application of the grey siding is nearing completion. This stage of the exterior facelift starts at the exit door near the boiler room and ends at the corner of exterior hall wall adjacent the chapel. The gym end wall above the chapel is near completion. Siding has also been installed on the west side gym wall.
- The chapel stained glass window has been removed and the wall temporarily closed to the elements. Modest finish work is nearing completion in the interior side of the closure. Reinstallation is expected in the spring of 2020 and a newly fabricated tracery will be installed ready for stained glass.
- Nine new windows have been installed in the Fellowship Hall, Bethany offices, and adjacent hall. Two remain but it appears the closure of winter will likely relegate this part of the window project to the spring of 2020. The Joseph Howe Drive tower has fallen to the fate weather. Siding will be expected in the spring.
- Winter weather has also impacted another Bethany project. The Church Spire will be "water tested" in the spring.
- Delays were a part of this, the first complete year of Options 1 renovations. Rot in numerous walls has caused delays in other aspects of building completion, i.e. the Tower on Joseph Howe. "Soft spots" number 22 and we cannot expect the count will be static in the future.
- Finally, the winter of 2019 saw the conclusion of structural and insulation of the Bethany basement. Started in 2018, the conclusion of a complex repair has helped to better warm the west end of our Bethany Structure.

The Board is great full for the generous donations from our Bethany community. These contributions have supported planned, and unplanned, portions of our renovations to date.

In league with congregant support, the Board secured a \$10,00 grant from the Province of Nova Scotia in 2019. This has supported the purchase and installation of the concrete ramp door.

The Hunter Fund application was met with success. Late in 2019 the Board of Managers was successful in securing a grant in the amount of \$50,000.

In 2020 the Board will pursue funding from the City of Halifax, The Government of Canada, The Province of Nova Scotia (again), and the United Church of Canada.

In terms of expenditures, the Board continues to balance renovation "pieces" between Options 1 elements and maintenance requirements. Put another way, Options 1 defines the renovation targets but not the soft spots, not obvious needs and not the unexpected problems of structural integrity.

Finally a communication strategy is being developed for the 2020 construction year. This will start with a scope of work description, under separate cover, informing the Executive Board members of the size and nature of this part of the construction phase. A financial description of this step is near completion.

I would like to end this report by acknowledging the endurance, energy, and foresight of Bethany's Board of Managers. Members continue to move forward on various fronts creating a better future for our Bethany community.

Put another way, surround yourself with smart people and it makes my job a lot easier.

TREASURER'S REPORT

I am happy to report that the donations from our congregation exceeded our budget for the third year in a row, with no need for a year end appeal. Our other sources of income – rentals within our facility, parking lot fees and, of course, the Fall Fair have all been on or over budget this year as well. When you take into consideration that our Capital Campaign is also receiving money from donations, it says a lot about the commitment of this congregation to keeping Bethany in a healthy financial position.

We were also very fortunate this year to have received a large bequest from the estate of one of our much-loved parishioners, Shelia Piercey who was always a generous supporter of Bethany. This money will become part of our investment portfolio and will be administered by the Board of Trustees.

2020 will be a challenging year for Bethany in many ways. Several of the major components outlined in our Options 1 project will be taking place this summer and into the fall. These are outlined in detail in the Capital Campaign Report found elsewhere in this annual report. This will impact our finances in two major ways: as the required space will not be available, there will not be a Fall Fair held this year, which has been a large part of our extra activities income; and we will be spending a fairly large sum of money on work in the Sanctuary which is not covered under the Options 1 plan. This work is critical for the structural, functional, and aesthetic integrity of the Sanctuary, and for reasons both practically and fiscally prudent, is best undertaken while the Sanctuary is empty over the summer and early fall of 2020.

In 2018, the Options 1 project was presented to the congregation and put to a vote, which passed with 98% of the membership in attendance in support. The financial goal was set using figures that were available and realistic at that time. Since then, costs have increased, as well as the scope of work to be accomplished. Other issues previously unknown and related to the structural integrity of Bethany's facilities have arisen during the course of this extensive renovation, and these, of necessity, have had to be addressed as they were encountered. While all items of the project deemed of primary and secondary importance will have been addressed by the end of 2020 using currently available funds, it is anticipated that another congregational meeting will be required to deal with the extra costs that will be needed to fully complete this project. In the meantime, rest assured that the Board of Managers is exploring all possibilities for additional sources of funding and has already been successful in obtaining two grants totally \$60,000. The congregation will be updated as these fundraising efforts continue.

Thank you for the opportunity to serve the Bethany community in the capacity of treasurer.

THE EARLE AND JANET REID SCHOLARSHIP FUND

Under the provisions of his Last Will and Testament, Dr. Earle Reid generously donated to Bethany United Church the sum of \$100,000.00 to fund the Earle and Janet Reid Scholarship Fund ("the Fund"). Under the provisions of his Will, Dr. Reid provided that the net annual income of the Fund be distributed annually by Bethany by awarding two annual scholarships to recipients attending a secondary or post-secondary educational institution who are active participants in church activities.

The funds were transferred to the Community Foundation of Nova Scotia to invest on Bethany's behalf. CFNS is a public charitable foundation established by Nova Scotians for Nova Scotians which works with private donors to build the financial and social capital of our community by establishing permanent endowment funds and providing the expertise to maximize the benefit to each of these funds. Since all the funds of the CFNS are pooled and invested together, the CFNS is able to keep investment costs low in order to maximize the benefit of each endowment fund. The monies in the Fund are invested in a balanced fund comprised of 60% equities and 40% fixed income. The CFNS charges an annual management fee of 1.77% for each fund and provides annual and quarterly reports.

Under the terms of Bethany's agreement with the CFNS, an Adjudication Committee consisting of three members of the congregation and a representative of the CFNS has been established to review all applications for the two annual scholarships and to recommend the two annual recipients of the scholarships as set out in Dr. Reid's Will and then to forward their recommendations to the CFNS's Board of Directors for final approval. In 2019, the three members from Bethany who sat on the Adjudication Committee were Beth O'Brien, Nancy Dearn and Greg McConnell. The CFNS is responsible for promoting the Fund.

This past year (2019), the two annual scholarship awards were granted in the amount of \$2000 each to Abigail Hanson (Port Wallis United Church) and Spencer McFarland (Bethany United Church).

CAPITAL CAMPAIGN REPORT

In May 2018 the congregation approved a plan to renovate and repair our church premises. Shortly thereafter the Stewardship committee organized a sub-committee to begin a capital campaign to fund these renovations/repairs. As most of you know, during the fall of 2018 and winter/spring of 2019 the committee canvassed members and adherents of Bethany and as reported to the congregation we were successful in raising over \$1,200,000 which was the initial campaign goal. This could not have happened without the generosity of so many of you. To date in excess of 100 Bethany families have contributed to the Capital Campaign.

Funds pledged and contributed to December 31, 2019:

- Funds received \$1,037,506
- Funds pledged but not received \$292,244
- Total committed to Capital Campaign \$1,329,750

Funds expended to date \$667,837 and work in progress* estimated at \$71,000 as follows:

- Engineer's drawings for Fellowship Hall floor projects
- Structural remediation of load bearing walls and footings under Fellowship Hall
- Removal of debris from Fellowship Hall and Gym crawl spaces
- Spray foam perimeter wall and floor under Fellowship Hall and Gym
- Install vapour barrier and HVR units under Fellowship Hall and Gym
- Replace exterior rotted sill under stage in Fellowship Hall
- Repair structural truss support next to kitchen
- Soft wall repair on exterior of Fellowship Hall, kitchen etc.
- Install new support beam under floor in washrooms adjacent to Fellowship Hall
- Replace 2 windows in kitchen
- Install lights for crawl spaces under Fellowship Hall and Gym
- New concrete ramp and railing at side of Fellowship Hall
- Replace shingles on Fellowship Hall and adjacent walls with vinyl shingles or siding and all associated work including repairing any rot found in walls (in progress)*
- Replacement of exterior windows in Fellowship Hall
- Replacement of Chapel roof
- Replacement of Gym roof
- Replace 3 windows in Gym
- Renovate hallway adjacent to Ladies Parlour, Boardroom etc., including new wiring, foam insulation and new ceiling
- Renovate Janitorial storage room, including new sink
- Investigate & repair gaps in corridor floor between chapel and Fellowship Hall

As you can see from the work done to date Phil Reardon, our Project Manager, and his team have been very busy over the past 2 years. Unfortunately a good deal of this work is not readily discernable to the naked eye but necessary none the less. An item like the structural remediation of load bearing walls and footings under the Fellowship Hall is essential to the structural integrity of the Hall itself but work that we as laypeople would not see being completed. It is also very expensive work and difficult to predict costing in advance. The good news is most of the work planned for the Fellowship Hall, gymnasium and Chapel has now been completed. Lead paint found on the tracery of the stained glass window in the Chapel means this has to be completely replaced, rather than just repaired, as had been planned. This will be part of the work undertaken in 2020.

The plan for 2020 is to concentrate on renovations/repairs to the Sanctuary. This will be a major undertaking that will disrupt our ability to use the sanctuary while this important work is done. The hope is to do as much as possible during late spring, summer and early fall. We will move to the Fellowship Hall for services and other events during this time. We ask for your understanding while these important and necessary renovations are completed.

We want to thank everyone who has contributed to this important capital campaign. As with many projects of this nature, many of the repairs done to date have unfortunately cost more than the amount budgeted. Even though we exceeded our initial goal, more funds will be required to complete all the projects. The Board of Managers is exploring all possibilities for funding sources and already has been successful in obtaining two grants totaling \$60,000. We will keep the congregation updated as these efforts continue.

In case you are wondering, it is not too late to make a contribution if you have not already done so. FALL FAIR REPORT

"PROVIDING AN AWESOME EXPERIENCE OF GOD'S LOVE."

October 19, 2019 was a banner year for our annual Fall Fair with 618 people attending, an increase of 28.75% over last year. 170 volunteers including many new faces, worked tirelessly to make the event a success. The Fall Fair Convenors worked diligently to incorporate the suggestions from the 2018 Fall Fair Committee and to try some innovations this year. Our net proceeds this year were \$35,420.34.

Notable changes to the Fall Fair this year included:

- Name changes for some of the tables to provide more creativity and interest
- Increased admission to \$2
- Some tables were relocated for better access and overall traffic flow
- \$50 sponsorship for each table to help defray Fall Fair expenses
- In an attempt to be more eco-friendly cloth tote bags printed with Bethany United Church and the United Church Logo were donated by the Tozer family for sale, with all proceeds going to the Fall Fair
- 40 Fruitcakes were donated for sale in lieu of a cash donation, with all proceeds to the Fall Fair
- Left-over merchandise was donated to the Mission Thrift Store, a "faith based organization" with a mission "to empower lives in the local community, reducing waste by giving items a new life. Mission Thrift Stores work with various local agencies to provide donated items to people in need due to fire, homelessness or other crises." Also, "all donated goods are converted to cash and invested in leadership/literacy programs in over 40 countries enabling access to the empowering message of the Word of God." Goods were also delivered to the Mission Mart, a faith based program of Souls Harbour Rescue Mission whose drop in centre provides "up to 100 hot, nutritious lunches every weekday. Guests include men and women facing hunger, homelessness, poverty, abuse and addiction."
- Opening our doors to "Non-profit" organizations for a 1 hour free shopping spree to provide items for their clientele. Although this endeavour was not embraced by the many organizations approached, the general consensus of the Table Chairs was that this avenue is worth pursuing in future. ISANS did avail themselves of this initiative and showed great appreciation for our generosity. Many items were also delivered to Adsum House, which derives from Latin meaning, "I am here." It is a safe place and support to women and families who are homeless and without resources.
- Brown Bag Lunches were made by the Youth Group and distributed to volunteers. The bags included a sandwich wrap, fruit and a sweet. Water was also provided along with free coffee/tea to all volunteers throughout the day.

During the week of November 18-21, the Fall Fair Convenors met with table chairs and some volunteers gathering input and suggestions for a future event. The following are "over-arching" comments:

What Worked

- The chowder luncheon and gingerbread desserts were good and chowders "tasty"
- The luncheon tables set-up and décor were attractive
- The Fall Fair was organized and ran smoothly
- Volunteer Handouts and Silent Auction Guidelines were well received, including an Evacuation Plan
- Chairs liked the idea of a convenor designated to each section of the facility; Fellowship Hall, Gym and Perimeter
- The volunteer lunches were much appreciated and tasty
- The cash boxes worked well
- The white bags and PAID stickers worked well to identify products sold
- Using bookcases increased visual display area and provided more space for product on tables
- Bethany's summer student Loch Williams was a tremendous help
- The teamwork displayed in the Furniture department was great
- Testing all the electronics was big job but well work the effort
- Re-arranging spaces for specific tables worked well
- The donkey and his side-kick were a big hit; statistics show that at least 7 people attended the Fair as a result of the Rotary advertising

Considerations for Improvement

- Streamline the volunteer lunch process, changing the menu to foods that can be prepared ahead of time; table representative to pick up volunteer lunches from designated area
- Ice Cream Shack didn't work so well due to cold weather
- Reinstate a variation on the "cake walk" i.e. cupcake walk or donut walk
- Locating Toyland outdoors was good for more space in the building but limited set-up time and provided less time to identify inventory on-hand
- Create a Media Table by expanding the Book table to include DVDs, CDs, LPs, Comics and hardcover books on all topics
- Weather affected activities and booths located outside
- Volunteer lunches had an impact on BBQ sales
- Along with sponsor signs, individual table signs are needed; route maps posted throughout the building not enough
- No rentals should be booked for 2 weeks prior to the Fall Fair

- Email/contact university and college campuses prior to sale as students are always looking to pick up inexpensive furniture/décor items for their accommodations
- Consider changes to Volunteer Friday evening shopping

Considerations for Improvement (continued)

- Using Fellowship Hall entrance rather than the ramp access poses a safety concern; in future ramp entrance to be used exclusively
- The Fellowship Hall should not be used for sorting the week of Vacation Bible School
- The white board for pricing at the Pantry Table was great
- More soups needed for Meals to Go
- Standardized recipes worked well
- Consider having a few events for making jam, jellies, pickles and soups prior to the Fair
- Ensure communication with the Property Committee of the Board of Managers on a regular basis
- ½ price sale could start a bit earlier
- Do not accept computers in future as they are outdated quickly and disposing of them difficult
- Fall Fair spread over longer period; i.e. 2 days
- Table Chairs and Convenors could drop into Wednesday and participate in sorting
- Table Chairs might look at preparing a handout for the Sorting team of items that are accepted for the table
- Reinstitute "fill a bag"
- Continue efforts for a "greener" Fall Fair by using re-usable signs, picture frames for pricing, recyclable food containers as examples
- Improve administrative process for "after-sales" and maintain flexibility to accommodate rentals that may affect "after-sales" (Federal Election this year)

Mary, Betty and Julie would like to express our gratitude to each and every person who made this year's Fall Fair a success. Bethany United Church is blessed to have so many talented, committed people who share their talents and gifts selflessly, serving as we are called.

Each of you should use whatever gift you have received to serve others, as faithful stewards of God's grace in various forms. 

BOARD OF TRUSTEES REPORT





During the year we have continued to hold special worship services including; monthly Jazz Vespers Services, New Members Sunday, Lent Communion and Worship Service, Service of Darkness on Good Friday, Palm Sunday Jazz Service, Easter, World Wide Communion, Thanksgiving, Children's Sunday, Remembrance Day, Advent Services, Service of Lessons and Carols, Christmas Children's Pageant, and Christmas Eve Communion.

LOCAL OUTREACH MINISTRY

Jesus said, "For I was hungry and you gave me something to eat, I was thirsty and you gave me something to drink, I was a stranger and you invited me in.

I needed clothes and you clothed me. (Matthew 25:35-36)

Local Outreach is a ministry of session and is directly supported by the congregation through designated contributions in the weekly offering envelopes. On behalf of Bethany Church, this money is used to serve persons in need of food and clothing items in the Metro area. A list of community agencies supported during the past year may be found in the Committee's financial report.

This past year we served our traditional meal of ham and scalloped potatoes at the St Andrew's Sunday Suppers in January, June and November. On average 150-200 people attend the supper, enjoying this hot meal and voice their appreciation of our continued ministry. The supper is a very rewarding experience and a time of community for those who participate in meal preparation and serving this most worthy outreach. Many thanks to Bethany for providing fresh fruit for these suppers.

In May and November a No Food - Food Bank Sunday was sponsored by the committee to assist the Halifax West Ecumenical Food Bank. These efforts raised \$4300 for the Food Bank. The Committee also donated funds to supply snacks to the Phoenix Drop – In Centre where many at risk youth gather each day. The Bethany Youth Group also donated healthy snacks and fresh fruit to the Food for Phoenix program.

On a Saturday in March and November two teams of 9 people from Bethany arose in the early morning to cook and serve breakfast at the Brunswick Street Mission. This particular outreach is now a regular outreach ministry as many Bethany folk have offered their time and willingness to participate. The congregation kindly tosses loose change into a frying pan before the breakfast to cover the cost of groceries. It was brought to the committee's attention that the breakfast kitchen at the Mission was in need of a new industrial size coffee maker. The committee approved the purchase of a new coffee maker and it was donated to the Mission in May. This donation was greatly appreciated by all who coordinate and attend the breakfast.

In March the committee and congregation supported a new outreach initiative called **Dignity. Period.** This is a campaign to help people with periods in Nova Scotia afford the menstrual products they need. Nova Scotia is the province with the highest rate of food insecurity in Canada, with 1 in 6 households unable to afford healthy food, which means they also can't afford personal care products. **Dignity. Period.** is a campaign to get people talking about period poverty and taking action to address it. A collection box has been placed in the Narthex for donations of menstrual products. This campaign has been

well supported and donations are taken regularly to the HWE food bank, Chebucto Connections, Phoenix House and Brunswick Street Mission. Many thanks Bethany for supporting this important outreach ministry.

During the late fall, the Committee sponsored a number of projects to support programs during the Christmas season. Through our clothing box, the Brunswick Street Mission, Phoenix Programs for Youth, and the Salvation Army, received many articles of warm clothing. Many of you also generously donated non-perishable food items and funds to the Halifax West Ecumenical Food Bank to provide meals and Christmas dinners. In addition, 135 gifts were donated to the Angel Tree and were forwarded to the Salvation Army for distribution.

We were deeply saddened this past March, by the passing of Grace Veino, longtime member and past Chair of this committee. In Grace's memory a donation of \$500 was made to the Veino Family Scholarship for Phoenix Youth. Grace is greatly missed, but her passion for outreach and serving others will remain in our hearts and our continued service to those in need of a helping hand.

Anne Pugh, resigned from her position as Treasurer, in June. We are very grateful to Anne for her dedicated years of service to this committee and the greater community. We were pleased to welcome Gary Gallant as our new Treasurer. Gary first came to us by finding his way into the kitchen to help with Sunday Suppers. Thank you Gary for accepting the position of Treasurer and being part of the outreach team.

The committee wishes to thank the congregation for their warm and generous support, both financially and in other various ways over the past year. I would also like to thank the committee members for their dedication and efforts in the work that they do to serve others in our community. Thanks also to Dana Mills and Tina Gascon for their administrative assistance and support.

We would also like to thank Louisa Duck and the Bethany Sunday School, as well as the Bethany Youth Group for their continued support of Bethany's Local Outreach projects. It is greatly appreciated and a wonderful way to involve the youth of our community.

CHILDREN AND FAMILY CARE MINISTRIES

Over the last year, our Sunday School has numbered about twenty-five children, with weekly attendance of five to twelve. The children have studied Daniel, Jesus' ministry and miracles, the stories of Holy Week, stories of friendship in each Testament, the Exodus, and stories of Jesus' birth, The Sunday School prepared three services last year. On Sunday June 2, we held our annual Celebration Sunday service to mark the end of our year together. We presented three Grade 3 Bibles, and two of our six high school graduates were presented with prayer shawls. The other four were unable to attend, and received their shawls separately. Our graduates were Peyton Duggan, Hannah Cameron, Mya Aiken, Lucy Little, Michaela Hooper, and Lochlan Williams. Our pasta picnic immediately followed the service in the fellowship hall, and was enjoyed by all. On November 17, we held our annual Children's Sunday service, and introduced our fall project. We raised \$900 to purchase winter supplies for the United Nations High Commission for Refugees, to support those who are living in refugee camps through the winter months, a number that is at a record high. The money was raised through special collection envelopes over a two-week period, and through the sale of soup and cookie mix, prepared by our Bethany Youth Group. Our Christmas Eve service was well-attended, as always, and Dan Isner once again generously provided Rosie the Donkey for this service, as well as the Living Nativity on December 8, and we thank him for his continued kind support. This year, Hilary Richardson was Mary, and Ryan Rice was Joseph. Freya Gjesdal was our baby Jesus, granddaughter of Carolyn Kunz, and daughter of Bethany Kunz Gjesdal, who was the first actual baby to play baby Jesus on Christmas Eve, thirty-six Christmases ago. Music for all three services was provided by our JAM choir.

JAM continues to be a busy and active group of eight children. Shawn worked with the children on a wide variety of music, and we also worked on drama, public speaking, and enjoyed many games and stories. We added more bulbs to our butterfly gardens in the fall, so these should be lovely come spring. The children are very excited to see the results of their work. Diane Dingwell has volunteered regularly with the program over the past year, and we appreciate her support. She brings years of experience as a retired teacher, and a great sense of humour and fun that we all enjoy. Thank you, Diane.

Vacation Bible School was held in July with nine children ranging in age from five to twelve. Our theme was Superheroes of the Bible, and we had great fun learning about Noah, Moses, Jesus, and Paul. Charlotte Moase worked with us again, and we also had two junior high volunteers, Abby Titus and Maggie Duck. This allowed us to work in small groups and take trips to the park. The children had lots of active play, and a wide variety of activities based on Scripture stories as we talked about what it means to be a superhero, and how God can use any of us to do great things, even though we are perfectly ordinary.

Our Prayer Shawl ministry continues to be very active. We distributed twenty-one shawls last year, and continue to be supplied by dedicated crafters who are generous with their time and talents.

I thank you all once again for your continued support of our programmes, and I look forward to another wonderful year in 2020.

COMMUNITY ENGAGEMENT MINISTRY

Bethany's community spirit is much to be thankful for! This faith community comes together in many different ways, engaging all ages and embracing God's Word: "Love one another as I have loved you." It is a privilege to minister with each of you in my role as Community Engagement facilitator. At Bethany we have an extraordinary group of young people who enjoy being together on Sunday evenings. Some of the highlights for the Youth Group this past year included a board game night, skating on chocolate lake, cooking and sharing a meal together, yoga with Susan Zurawski, a visit from beloved dog Ginger Drake, an outdoor hike to collect litter and celebrate Earth Day, and an end of the year sleepover here at the church. During winter and spring the youth made healthy snacks once a month and donated them to a youth program at Chebucto Connections in Spryfield. We also supported a campaign called Dignity Period and invited founder Erin Casev to join us on a Sunday evening as we learned about period poverty and the need for feminine hygiene products in NS. The youth collected and donated such products to Chebucto Connections. In May the Youth Group led a Jazz Vespers service entitled Our Firm Foundation; also in May two Bethany youth attended Youth Forum and Intermediates at Maritime Conference. They met many youth from United Churches across the Maritimes as they explored their faith in a welcoming and safe environment.

We reunited in September with a bonfire and kayaking on Chocolate Lake. Some highlights of the fall were making food for Phoenix Youth, assisting with the Fall Fair and Silent Movie Event, making and selling soup and cookie mix jars to raise funds for UNHCR to purchase supplies for refugee camps during the winter months. 2019 came to a close with our annual Old Fashioned Christmas in support of Phoenix Youth. This year we combined this event with the Living Nativity. The youth group dressed in costumes, participating in the live telling of the nativity story. Thank you to all who assist with this combined event especially Louisa Duck, Laura King, Christie Chisholm and Dana Mills! Phoenix House is very thankful to Bethany for our continued support. Also many thanks to Dana for her continued support as a volunteer youth leader.

The JOY Lunch program also continues to thrive as the hospitality of our Bethany folk spreads beyond our doors. Special guests have included Debbie Simmonds from the African Baptist United Church; Dalhousie University students- Indigenous History and Health in Canada; Kevin Little shared Lucy's art project and trip to the National Centre for Truth and Reconciliation in Winnipeg; Kathy Brown shared her father's story who served some of the first missions of the United Church on Newfoundland; John Gillis spoke about the Senior's College of Nova Scotia; Gloria Stephens shared unknown stories of VG nurses in time of war; and Sorella Women's Choir presented music of the season at Christmas. Special thanks to Tim Cormier for his time and culinary skills and all those who assist in the kitchen and at the door; Barry Paton for technical assistance; and Rev. Kevin, Rev. Vince and Rev. Elroy for their prayers and blessings at each gathering.

Bethany's indoor walking program Walk and Talk is a great way for our community and the greater community to walk safely during the winter months. Each Wednesday morning a group of approximately 20 people enjoy walking laps throughout the building followed by coffee, tea, nutritious smoothies, crossword puzzles and conversation. Kevin joined us on the first Wednesday of each month, engaging us in a themed conversation. HRM Community Health Team member, Scarlett McMullen joined us once a month January –April with a variety of wellness programs. In

November Walk and Talk became a Senior's Drop- In program, where folks can come and sit and converse, walk indoors if they choose, enjoy music and singing in the parlour with Murray Brown on keyboard and Huntly Blair on percussion. At the morning's end people are invited to join the Essentrics Exercise, a 25 minute DVD led program which focuses on strength, flexibility and stability.

Guided Meditation led by Yvonne Macor, took place in the winter, spring and fall months on Thursdays. These sessions were held in the MacKinnon Chapel and were well attended by Bethany folk and the surrounding community. Meditation boasts many health benefits; resting and rejuvenating the mind, body, and spirit. We are very grateful to Yvonne for continuing to volunteer her time and talent as we form community meditating together, quieting our busy minds, enabling us to draw closer to the Spirit at work in each of us.

This past year Bethany volunteers continued to host a conversation circle with Immigrant Services Association of Nova Scotia (ISANS). Bethany volunteers supported ISANS instructor Julie MacDonald during three sessions; winter, spring and fall. A dozen or so Bethany volunteers, through a rotational schedule, enjoyed engaging in very beginning level conversation with new immigrants age 55 plus. These new Canadians are very grateful for our hospitality and love to thank us with food! We had a lovely picnic in the Piercey Garden in June and another feast in December. Due to scheduling conflicts the ISANS Sewing Circle, no longer meets here on a regular basis but we continue to store their sewing machines until a new class time can be arranged. Last winter and spring we were pleased to host two new immigrants from the ISANS program for disabled students, attend Walk and Talk each week with their instructors. Unfortunately their schedules changed for the fall and they were no longer able to attend. We keep our doors open and welcome any newcomers who may like to join us!

The Congregational Care Team of Bethany consists of volunteer lay persons offering care and support to our congregation. This ministry supplements the visitation ministry of our lead Minister. The Care Team offers support to those who may be housebound or in senior's residences and can no longer come to church, or to anyone who may feel isolated throughout the week and would appreciate a visit or phone call as well as drives to medical appointments. Visits and phone calls are made on a regular basis to those who have requested visits as well as those whom Kevin suggests through his visitation ministry. The care team delivered 20 UCW Christmas Gift Bags to parishioners in December. These gifts were much appreciated by those who received them.

As staff liaison to the Community Connections Working Group (formerly the Revelation Committee) we had a very successful trial run of offering Community Meals once a month January – April. These meals provide an opportunity for folks to prepare and eat a nutritious meal together. We hosted two lunch and two supper meals with an average of 25 people in attendance. The working group continues to be a support to the current community engagement programming as well as hosting community events and initiating new programs as the need arises. We are very pleased to have our new digital sign on Joseph Howe thanks to the visioning of the original 20/20 Team and the work of this Community Connections Group.

I would like to express my thanks to Kevin for once again inviting me to preside on Sunday mornings this past July, along with my colleague Louisa Duck, while he was on vacation. I thoroughly enjoyed ministering with you through word and song. I feel very blessed to be a part of this faith community as we continue to share God's love and serve others; walking, talking, eating and singing together on this journey as brothers and sisters in Christ!

DIRECTOR OF MUSIC MINISTRIES



As I write this annual music report I will have just completed my 23rd year at Bethany United serving as your Director of Music Ministries. Time certainly has a way of passing by especially when you are enjoying the various tasks involved with this position. The Bethany community has been a supportive and vibrant community especially when it comes to the sacred arts. This past year has been no exception and I now take time to review some of the activities and highlights of the past 12 months with regards to the music ministry programs at Bethany United.

Thomas Duck has returned for a second year to the Bethany Senior Choir under the auspices of the Lilian Piercey Music

Scholarship. Thomas will continue to sing with the choir during the year as he attends Citadel High School. He is very involved in the music program at his school including both choir and band programs at Citadel. Thomas will also use a portion of this scholarship to afford a trip to Cuba for further musical and artistic endeavours. Welcome back Thomas for another year of making music.

The Junior Choir at Bethany United is also a part of our Wednesday after-school program known as J. A. M. (Junior's on Adventure with Mission). We currently have 9 children attending this program each week for a 75 minute session that includes; singing, snacks, crafts, story time, and recreation time in our gym. The choir will also sing for services approximately once a month. This program is team led with Louisa Duck along with myself.

The Bethany Handbell Choir has enjoyed another year of ringing on our beautiful set of Schulmerich English Handbells. The group meets for weekly rehearsals and will present musical offerings approximately once monthly. The choir regularly participates in our Christmas and Easter services. This past year the Handbell Choir performed at two funerals for former choir members including Jean Frederick and Joyce Clarke. Both Jean and Joyce will be missed but it was with great pride and admiration that we were able to offer our music ministries at their services of celebration of life. In May of 2020 the choir will be travelling to Moncton NB for the Annual Spring Ring Handbell Symposium along with 12 other choirs from around the Maritimes.

The Bethany United Men's Choir includes approximately 14 tenors and basses that rehearse usually following our Thursday night rehearsal and will participate in 6-8 worship services per year. This group sings a variety of repertoire both traditional and contemporary in 2, 3, and 4 part harmony.

The Bethany Senior Choir continues to be the main ensemble at Bethany involved in worship services and provides wonderful leadership for our Sunday morning services. Our choir of adults singing in 4-part harmony rehearses weekly on Thursday evenings and participates in over 40 services per year including special services for Advent, Christmas, Lent, and Easter. They are constantly learning new music from a variety of time periods, world regions, and genres, up to and including contemporary repertoire. This group is extremely committed to the music ministry program at Bethany with approximately 34 members at present. This past year the choir performed a memorial concert in April celebrating the life of Janet Paton and a memorial Christmas presentation during the service of Lessons and Carols in memory of Peggy Starkes.


The Jazz Vespers Worship Series continued throughout the Spring of 2019 but took a break in the Fall of 2019. It was decided to present Jazz Services during morning worship on various Sundays throughout the year making this style of worship more accessible to our congregation and so these services will include: Ordinary Time in September, Advent 1, Lent 1, and Palm Sunday, and Pentecost.

Over the past year many concerts and musical events have happened at Bethany United. I would like to highlight a few of those events. A choral concert was presented in April in memory of Janet Paton and the main choral work presented was John Rutter's The Gift of Life. In December during the Annual Service of Lessons and Carols and in memory of Peggy Starkes the choir presented Cecilia McDowall's Christmas Cantata. Both these presentations were presented with great pride and in loving memory of these two choir members. A personal highlight for me was to present 'Another Night at the Movies' and accompany the comedy silent movie 'Safety Last.' The event was very well attended and proved to be an excellent fundraiser for the church. Personal thanks to Barry Paton for all of his technical support in the presentation of this event.

Personally, I continue to hold memberships with the Royal Canadian College of Organists, The Early Music Society of Nova Scotia, the NS Music Educators Association, and the NS Kodaly Society. This past summer I attended the National Convention of the RCCO which was held in Halifax and this symposium turned out to be an excellent opportunity for continuing education and further networking. I continue to teach organ privately and currently have four students. I also continue to volunteer for Habitat for Humanity and during this past summer I was a crewleader at the Spryfield build site.

COMMUNITY CONNECTIONS WORKING GROUP

The Community Connections Working Group (CCWG) is a follow-up group to the Revelation Committee which was mandated to implement recommendations from the 20/20 Visioning process. 2019 was the second year for the CCWG to facilitate community interaction at Bethany.

The Walk and Talk program, now called the Seniors' Drop-In program, continues to be a popular choice. It includes safe winter walking (if you wish) through the meandering network of spaces and corridors of our church, and of course talking and socializing. There is also an option to join in a late morning exercise group, Essentrics, a 25 minute DVD led routine.

Hosting the ISANS Conversation Circles continued throughout the year with appreciation and enjoyment expressed by those who participated. Interaction with newcomers proves to be interesting and rewarding on many levels. Anyone wishing to become engaged with future interactions can do so by speaking with Ann or Cheri.

Our community meals program is one which brings Bethany people together for sharing a lunch or dinner. The idea of this program is to give people a chance to "eat out" among friends. We focus on healthy, nutritious, sustainably grown, and delicious meals families can enjoy as they would their own home-cooked meals. There is also the option, for those who wish, to come in ahead of time and help with the cooking, or to stay after the meal and help with the clean-up. We want the community meal experience to make you feel "right at home".

The first and foremost recommendation recorded in the 20/20 Visioning report was to invest in a digital sign for the Joseph Howe Drive side of the Bethany premises to enable communicating with the broader community and to draw people into our Bethany community. This was finally achieved by the CCWG and our sign is now an active part of the Armdale neighbourhood. An HRM grant of \$15,000 made the purchase and installment of the sign feasible, and several donations have been made by other committees and by individuals. There is still approximately \$15,500 owing and the CCWG will be holding fund raisers to pay for the balance. If you would like to support this important new step in growing our church by making your own donation, your help would be greatly appreciated.

The CCWG hopes its work will build the meaning of "church community" in all our hearts, and you will find the programs we continue to develop, bring a deeper sense of family and belonging to everyone. We believe a church is a place that is uplifting, fulfilling, caring, safe and supportive every day of the week. We believe every person is a vital part of our whole.

- The Bethany Memorial Flower Fund banking institution issued instructions not to roll-over interest on GIC's for reinvestment but to be deposited to the current account for eventual distribution.
